### **DECISION AWARDING DAMAGES**<sup>1</sup>

**Dorsey**, Chief Special Master:

On June 13, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she suffered a left shoulder injury related to vaccine administration (“SIRVA”). Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On March 5, 2018, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On July 30, 2018, respondent filed a proffer on award of compensation (“Proffer”) indicating petitioner should be awarded \$151,137.12, consisting of past unreimbursed medical expenses (\$3,637.12), and pain and suffering (\$147,500.00). Proffer at 1. In the Proffer, respondent represented that petitioner

agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$151,137.12 (consisting of past unreimbursed medical expenses (\$3,637.12) and pain and suffering (\$147,500.00)) in the form of a check payable to petitioner, [REDACTED]** This amount represents compensation for all damages that would be available.

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>

**RESPONDENT’S PROFFER ON AWARD OF COMPENSATION**

On June 13, 2017, [REDACTED] (“petitioner”) filed a petition for vaccine injury compensation alleging that she suffered a left shoulder injury related to vaccine administration (“SIRVA”). On March 5, 2018, respondent conceded that entitlement to compensation was appropriate under the terms of the Vaccine Act. The same day, Chief Special Master Dorsey issued a Ruling on Entitlement, finding that petitioner was entitled to vaccine compensation for her SIRVA.

**I. Items of Compensation**

Based upon the evidence of record, respondent proffers that petitioner should be awarded \$151,137.12, consisting of past unreimbursed medical expenses (\$3,637.12), and pain and suffering (\$147,500.00), which represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a).<sup>1</sup> Petitioner agrees.

<sup>1</sup> Should petitioner die prior to entry of judgment, the parties reserve the right to move the Court for appropriate relief. In particular, respondent would oppose any award for future medical expenses, future lost earnings, and future pain and suffering.

**II. Form of the Award**

The parties recommend that the compensation provided to petitioner should be made through a lump sum payment of \$151,137.12 in the form of a check payable to petitioner.<sup>2</sup>

Petitioner agrees.
