### **DECISION AWARDING DAMAGES**<sup>1</sup>

Dorsey, Chief Special Master:

On January 5, 2018, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of a hepatitis B vaccine received on March 25, 2016. Petition at 1-2. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On February 26, 2019, a ruling on entitlement was issued, finding petitioner entitled to compensation for his SIRVA. On May 10, 2019, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$74,622.76 (representing \$72,500.00 for pain and suffering and \$2,122.76 for past out-of-pocket

medical expenses). Proffer at 1-2. In the Proffer, respondent represented that petitioner agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards** petitioner a lump sum payment of \$74,622.76 (representing \$72,500.00 for pain and suffering and \$2,122.76 for past out-of-pocket medical expenses) in the form of a check payable to petitioner, This amount represents compensation for all damages that would be available under § 15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>

### **RESPONDENT'S PROFFER ON AWARD OF COMPENSATION**

On February 26, 2019, respondent filed a Rule 4(c) Report, conceding that petitioner's

claim meets the Table criteria for a SIRVA injury. On that same date, the Court issued a Ruling

on Entitlement finding petitioner entitled to compensation under the Vaccine Act.

### I. <u>Items of Compensation</u>

Based upon the evidence of record, respondent proffers that petitioner should be awarded

the following, and requests that the Chief Special Master's decision and the Court's judgment

award:

- 1. A lump sum payment of \$72,500.00, which represents compensation for pain and suffering, *see* 42 U.S.C. § 300aa-15(a)(4); and
- 2. A payment of \$2,122.76, which represents compensation for past out-of-pocket medical expenses, *see* 42 U.S.C. § 300aa-15(a)(1).

These amounts represent all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a).<sup>1</sup> Petitioner agrees.

#### II. Form of the Award

Petitioner is a competent adult. Evidence of guardianship is not required in this case. Respondent recommends that petitioner be awarded a lump sum payment of **\$74,622.76**, in the form of a check payable to petitioner. Petitioner agrees.
